ORDER
20-015

The Court accepts the recommendations of the Board of Bar Examiners and orders that each applicant who sat for the February 25-26, 2020, bar examination and attained a total grade of 274 or more, whose name appears on the attached Exhibit A, be admitted to the practice of law, except as follows:


1. As to those persons otherwise eligible for admission to the practice of law in Oregon but who have not passed the Multistate Professional Responsibility Exam (those persons on Exhibit B), upon receipt by the Court of notice from the Board that any such person has passed the MPRE, such person shall be admitted to the practice of law without further action by the Court, if the applicant is eligible to execute, and actually executes, the oath of office for the practice of law within 13 months of the date of notice that the applicant passed the bar examination.

2. As to those persons otherwise eligible for admission to the practice of law in Oregon but for whom have not graduated from an ABA accredited law school. Those persons are listed on Exhibit C.

3. As to those persons otherwise eligible for admission to the practice of law in Oregon but for whom the Board has not completed its character and fitness investigation, upon receipt by the Court of the Board's affirmative recommendation for admission on character and fitness grounds of any such person, such person shall be admitted to the practice of law without further action by the Court, if the applicant is eligible to execute, and actually executes, the oath of office for the practice of law within 13 months of the date of notice that the applicant passed the bar examination. Those persons are listed on Exhibit D.

Admission of applicants under this order shall be effective upon receipt by the State Court Administrator of an executed oath of office, as provided in Rule of Admission 8.10.
